MINUTES OF THE ANNUAL AND EXTRAORDINARY SHAREHOLDERS' MEETING HELD ON APRIL 17, 2013

Minutes of the Annual and Extraordinary Shareholders' Meeting of ALL – América Latina Logística S.A. ("Company") held on April 17, 2013, drawn up in summary form:

- **1. <u>Date, Time and Venue.</u>** April 17, 2013, at 4:00 p.m., at the Company's headquarters, located at Rua Emílio Bertolini, n.° 100, Bairro Cajuru, in the City of Curitiba, State of Paraná.
- **2.** Call Notice. The call notice was published in the *Diário Oficial do Estado do Paraná* on April 2, 3 and 4, 2013, respectively, on pages 87, 55 and 65, and in the *Gazeta do Povo de Curitiba* newspaper on April 2, 3 and 4, 2013, respectively, on pages 3, 3 and 5.
- **Attendance.** Shareholders representing 60.07% of the Company's voting capital, as per the signatures in the Shareholders' Attendance Book. Raimundo Pires Martins da Costa, member of the Company's Board of Directors; Ricardo Scalzo, member of the Company's Fiscal Council, and Adriano Machado, representative of the Company's independent auditors, also attended the meeting.
- **4. Presiding.** Raimundo Pires Martins da Costa, Chairman; and Carlo Sivieri de Assis Rocha, Secretary.
- **Resolutions.** The attending shareholders resolved the following, with abstentions and abstaining from voting those legally impeded:
- **5.1.** To authorize the drawing up of the minutes of the Annual and Extraordinary Shareholders' Meeting in summary format, as well as their publication without the signatures of the attending shareholders, pursuant to article 130 of Law 6404/76;

5.2. Annual Shareholders' Meeting:

- **5.2.1.** Following analysis and discussion, to approve by majority of votes the annual report, administrators' accounts and financial statements for the fiscal year ended December 31, 2012, accompanied by the independent auditors' report, which were published in the *Diário Oficial do Estado do Paraná* newspaper (pages 35 through 48) and in the *Gazeta do Povo de Curitiba* newspaper (pages 6 through 11) on March 6, 2013.
 - **5.2.1.1** To acknowledge, pursuant to article 163, items II and VII of Law 6404/76, that the Company's Fiscal Council approved the management report and financial statements for the fiscal year ended December 31, 2012, in accordance with the minutes of the meeting held on February 28, 2013.
- **5.2.2.** To approve by majority of votes the allocation of the net income related to the fiscal year ended December 31, 2012 proposed by the Company's administration, as follows: (i) R\$11,865,700.78 to the constitution of the legal reserve (article 193 of Law 6,404/76);





- (ii) R\$56,362,078.69, equivalent to 25% of adjusted net income, to be distributed as dividends, which will be credited on June 14, 2013; (iii) R\$53,313,722.00 to the tax incentive reserve; and (iv) the remaining R\$115,772,514.07 to the investment reserve (article 36 of the Bylaws).
